#### Left behind audio theater

When audio CDs are a recording of a radio program based on a book, class the CDs the same genre as the book.

Language CDs (8-2004)

All language materials will be cataloged according to their respective chapters in AACR2, 2002 revised ed.

Publisher's name or phrases should not be included as part of the title. Title is taken from the CD, not the container. An added title entry with the publisher's name or phrases should go in the 246 field.

Examples: Barron's mastering Italian (Title on container)

245 00 Mastering Italian (Title from CD label)

Add a 246 for the title on the container.

Example: 246 3 Barron's mastering Italian

Language CDs only—no book

Language CDs will be title main entry, unless there is an author's name on the CD label in which case the CD should be cuttered with this.

# Language CDs with an accompanying book

If the language CD has an accompanying book, it will have a cutter according to the JCL guidelines for books. These CDs will be cuttered with the author of the book that is part of the set.

Language CDs without a book, but a corresponding book is alone in the JCL collection

In this case cutter the CD to match to book, so that they will sit together on the shelf.

# **Checking in SIRSI**

### Adds

Items may be added to an existing SIRSI record even if they do not exactly match the existing record, if one or more of the following criteria exist:

- 1. The label is different, but the title, cast and running time match the existing record.
- 2. There is a different ISBN or edition, but the narrator, running time and title are the same.
- 3. The copyright date on the item in hand is different, but everything else is the same.
- 4. You may add an item to a record if it matches the bib record, but the number of CDs differs from what is one the bib record. However, you must add a 500 note to the record stating that some copies may not contain the same number of CDs. Also make sure when you inventory a CD that you put the correct number of pieces for all items attached to the bib record.

### **New Record**

Create a new record in SIRSI, when the title, cast and time are the same as an existing record, but one or more of the following criteria exists:

- 1. Do not put abridged and unabridged items on the same record.
- 2. The narrator is not identical
- 3. Running time is off by more than a couple of minutes.

### **Checking in OCLC**

When doing a title search in OCLC for an CD audiobook, enter /rec to limit the search.

Date on the spine label is the year the item was recorded. Add the date so that it will appear on the spine label for a performance copyrighted during the current year.

For searching and formatting for the hit list, the contents of the n subfield should be standardized for the titles within a run. The volume number in the subfield n is included in the call number in the 092 field and is formatted according to the instructions in the *Volume field guidelines*.

# p subfield in the 245 field

When an h subfield is necessary, it follows the n subfield, but precedes the b subfield. Since the numbering is in the n subfield, it is unnecessary to enter the numbering in the h subfield.

For searching and formatting for the hit list, the contents of the n subfield should be standardized for the titles within a run. The volume number in the subfield n is included in the call number in the 092 field and is formatted according to the instructions in the *Volume field guidelines*.

Add numbering of volume, if available in subfield "v" to 490 and 8XX fields, as available.

Place all titles in a fiction series in the same genre (e.g. Fiction, Mystery, Science fiction).

Leave all series in a record.

If the authority record says "use as quoted note", change the 4XX/8XX fields to a single 500 note field.

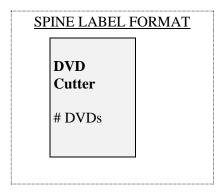

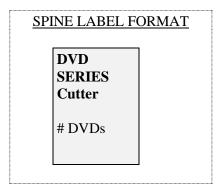

## **Packaging**

Adult DVD's that come as a set can be kept as a set, divided up into single cases or divided into sets decided upon by the AV selector. A season of a television program will be kept as a set. If the A/V selector foresees a problem when ordering, a note will be placed in the SIRSI order-line. When it is received in Technical Services the packaging can be reviewed.

Sets that have individual titles and their own artwork can be packaged separately as decided by the AV selector (5-2007).

# **Checking in SIRSI for ADDS**

Items may be added to an existing SIRSI record even if they do not exactly match the existing record, if one or more of the following criteria exist:

- 1. <u>Number of discs differs</u>: If the additional discs contain only added material and the actual DVD is the same, add a 590 note that some copies may contain a different number of discs. When adding copies, be sure to indicate in a circ note that the number of discs for the copy in hand. Circ note should be all in CAPS.
- **2.** The **distributor** is different, but the title and cast match the existing record.
- **3.** There is a <u>different ISBN</u>, series, etc., but the title and cast are the same. Add all new ISBN's to the record.
- **4.** The DVD is a **colorized version**, and the record is for a black and white copy.
- 5. The **copyright date** on the item in hand is different, but the title and cast are the same.
- **6.** <u>Full screen verses widescreen</u>: Use the same record and note in the bibliographic record in the 590 field the different versions for each library.

Example: 590 Johnson County Library's copies are full-screen.

- 7. Regular edition verses special edition: In this case, the special edition is usually the movie on one disc with additional features on the second disc. Use the same record and note in the bibliographic record "Olathe Public Library copies are special editions with 2 discs".
- **8.** Rated verses Unrated. In some cases both the rated and the unrated copies of a popular DVD will be on the same record. If this is the case please add a 590 note to the bibliographical record.

### Operas on DVD

If an opera performance is filmed it is classified as 782.1 and the loan period is 21 days. However, if an opera is made into a movie it is a 7 day DVD.

# **Checking SIRSI for ADDS**

Items may be added to an existing SIRSI record even if they do not exactly match the existing record, if one or more of the following criteria exist:

- 1. Number of discs differs If the additional discs contain only added material and the actual DVD is the same, add a 590 note that some copies may contain a different number of discs. When adding copies be sure to indicate in a circ note the number of discs for the copy in hand. Circ note should be all in CAPS.
- 2. The **distributor** is different, but the title and cast match the existing record.
- 3. There is a <u>different ISBN</u>, series, etc., but the title and cast are the same. All all new ISBN's to the record.
- 4. The DVD is a **colorized version**, and the record is for a black and white copy.
- 5. The **copyright date** on the item in hand is different, but the title and cast are the same.
- 6. **Full screen verses widescreen**: Use the same record and note in the 590 field in the bibliographic record that some copies are full screen and others widescreen.

7. **Regular edition verses special edition**: In this case, the special edition is usually the movie on one disc with additional features on the second disc. Use the same record and add a 590 field to the bibliographic record (e.g.,Olathe Public Library copies are special editions with 2 discs).

- The same bibliographic record can be used for both adult and juvenile collections.
- Adult PC games on CD-ROM are cataloged as video games.

# **SUBJECT ACCESS:**

Add appropriate subject headings as necessary with the subdivisions "Software" or Juvenile software. Add headings for the type of computers "IBM-compatible computers" and/or "Macintosh (Computer)" with the appropriate subdivisions |v Software or |v Juvenile software.

#### **CHECKING IN SIRSI**

An item is an add if the title is the same and the system requirements (538 notes) are identical.

An item is an add if the version statements differ, but the system requirements are identical.

Serials: If the system requirements change from one year to the next, add the new system requirements as the first note with the year in parenthesis.

Files that are mostly alphabetic information (words or sentences) converted into a code that can be processed, sorted and manipulated by machine, and then retrieved in many optional formats. Use for records containing full text of documents and material intended to constitute a textual document whether represented as ASCII or image data.
- e Bibliographic data. Data are bibliographic citations, including library catalogs or citation databases. May be structured or unstructured.
- f Font. File contains information for a computer to produce fonts.
- g Game. File is for recreational or educational use. Usually text and software, including video games.

Add the Universal Product Code, if it is not on the record. Indicators are 1 blank. When adding the code to a record, use the 12 digit code. If the container and the jewel case have different Universal Product Codes, use both codes and identify the source of each one.

### **037** Source of Acquisition

Indicators are blank.

Subfield a: contains the stock number. The numbers are usually found on the disc labels.

Subfield b: contains the source of the stock number. This should match the 260 field, subfield b.

### 041 Language code

Used for CD-ROMs that teach a foreign language.

Indicators: 0 blank Use if the CD-ROM is **not** a translation

1 blank Use if the CD-ROM is a translation.

Subfield a: Contains the code or codes for the language of the CD-ROM.

Use the code of the predominant language first. If two or more languages are used, use

separate subfields a.

The predominant or first language in an alphabetical string should also be listed in Lang

in the fixed field.

- All cutters for CD-ROMs are title entries, and are limited to the first eight letters of the first significant word.
- Following the cutter add the type of machine the CD-ROM can be played on. For example: IBM for materials that are IBM compatible, MAC for items that are compatible with Macintosh computers, and IBM/MAC for dual platform CD-ROMs.
- Refer to cuttering policies for spine labels.

### 1xx Name

There should not be any 1xx fields, as all CD-ROMs are title main entries.

# "n" subfield in the 245 field

The n subfield generally occurs in 245 fields when the a subfield of the 245 is not unique and the only difference is numbering which does not signify a part.

When an h subfield is necessary, it follows the n subfield, but precedes the b subfield. Since the numbering is in the n subfield, it is unnecessary to enter the numbering in the h subfield.

For searching and formatting for the hit list, the contents of the n subfield should be standardized for the titles within a run. The volume number in the subfield n is included in the call number in the 092 field and is formatted according to the instructions in the *Volume field guidelines*.

# p subfield in the 245 field

The p subfield displays in iBistro, but not in Workflows.

One configuration is an a subfield with a non-unique title and a unique subtitle in a p subfield of the original OCLC record. Graphic novel series and television series are some of the materials that may have this configuration of title.

When an h subfield is necessary, it follows the p subfield, but precedes the "b" subfield. The general rule is to change the p subfield to a b subfield. Refer to the appropriate sections of the manual for the current configuration of titles with this subfield.

Use for the version of the CD-ROM. The form usually will be Ver. and a number, such as 1.1.

# 4XX/8XX Series

Verify if the series authority record for series title exists in the catalog. Add authorized form if available. Use 490 0 field for series statements that are not traced. For series with authority record, use 490 1 for series traced using a modified form of the series title in the 8XX field.

*Volume Numbers* – "v: " subfield

Add numbering of volume, if available in subfield "v" to 490 and 8XX fields, as available.

Place all titles in a fiction series in the same genre (e.g. Fiction, Mystery, Science fiction).

Leave all series in a record.

If the authority record says "use as quoted note", change the 4XX/8XX fields to a single 500 note field.

If there is no series authority record available in Sirsi, add a 490 field, first indicator 0, second indicator blank, subfield "a" SERIES to bibliographic record.

Example: 490 0 SERIES

A JCL cataloguer will add an authority record, make changes to the bibliographic record as necessary and remove 490 0 SERIES.

### 538 System Requirements Note

Make this the first note.

Begin each note with System requirements.

If you have a dual-platform CD-ROM, add the type of computer in parenthesis after "System requirements". Make separate 538 fields for each platform.

Copy the system requirements from the container, jewel case or the company's Web site. Between the items in the list add a semicolon and a space.

#### 500 Source Notes

After the system requirements notes add 500 notes that designate the source of the title and the version. Combine them if both were found in the same area. If you found the title in one area and the version in another area, add two 500 notes.

### 511 Performer Note

Use if you find references to a narrator or cast.

Indicators are 0 blank for narrator. Indicators are 1 blank for cast.

This note is rarely used for CD-ROMs.

### 508 Credits Note

Use this field for the naming of directors, producers, programmers and others who have contributed to the CD-ROM. Usually this information can be found in the last pages of the accompanying booklets.

No indicators.

Add as deemed necessary.

# <u>521</u> Target Audience note.

Do not add, edit or delete.

# **520** Summary Note

Add a summary note to all records. If there is not one on the record, copy or modify information from the container or the company's Web site or write your own.

### **505** Contents Note

Use when there are two or more CD-ROMs, and they have distinct titles.

Add a 740 field for each title.

### **6XX** Subject Headings

All headings will have a subfield x at the end of the string. If it is an adult CD-ROM the subfield x will be as follows: ‡v Software.

All records shall have a 650 note stating on what type of computer the CD-ROM will work, e.g.:

- 650 0 IBM-Compatible computer ‡v Software.
- 650 0 Macintosh (Computer) ‡v Software..

#### **700** Author Added Entries

- Add 700 fields for all persons named in the 245, 511 or 508 fields.
