There are also collaborations beginning with Fab Newport, Innovation Hub, and Salve Regina Outreach. The Library would like to become a place to train patrons in rudimentary skills to take them into other areas.

The library is considering a Creative Aging program that we are hoping St. Clair's will help underwrite.
