

Newport Public Library Board of Trustees Meeting Minutes Teleconference Meeting June 18, 2020

- 1. Call to order: President Matthew Leys called the meeting to order at 4:33 PM.
- 2. Amendments to the Agenda: The agenda was approved as presented.
- 3. Minutes of the May 2020 meeting: The minutes were approved as presented.
- 4. Finance Committee Report:

Robin Skuncik Jones reviewed the May financials, income is down by over \$40,000 dollars. Fundraising, fines, gift and other income are down due to the 150th celebration cancelation and the library being closed. All fines have been canceled since March 1st. Salaries are down due to unfilled positions. Operation expenses down. Michael Dutton reported: Income down 4.4% mainly due to fundraising. Expenses down 29,562 14.8% drop mainly in salaries. Wells Fargo Investments up \$44,186 in April and \$26,095 in May. Expenses and materials budgets down, expect that will change in June.

5. President's Report:

- Building and Grounds Committee Report: The maintenance staff continues extensive daily cleaning during Covid conditions. Roof leaks continue, a new inspection is warranted at this time.

- 8. Friends of the Library Report:

Edwin Sebest reported that she is now the new President of the Friends. The Book Store has been closed and will remain closed for now. The lobby book sales are still available. They may begin having some volunteers working in the back processing area, limiting the number of them working at one time. They are now again accepting book donations.

9. Library Director's Report and Update:

Joe Logue, Introduced Patricia Fetta as the new Bookkeeper, her employment began on June 1st.

The library is in full compliance with Phase 2. A few patrons have refused to wear masks, on person had to be evicted. Wearing a mask is a condition of entry and patrons must stay 6' apart. The library is currently open 30 hours a week, closed on Mondays. Curbside service is still going well, we had implemented this service much earlier than other libraries.

10. Old Business:

150th Celebration has been moved to May 1, 2021 it will now be the 151st Celebration.

11. New Business:

The library has contracted with Paychex to begin processing payroll as of July 2020.
